Situated on a spacious 594m² freehold property, the purpose-built facility features an enclosed, heated 25m x 10m pool with five lanes, well-maintained changing rooms, reception, and office spaces. The brick building, supported by laminated wood beams, includes parking and space for expansion.

A team of 25 trained casual staff manages daily operations. The business benefits from steady enrolments and a growing revenue stream from private lane hires for physiotherapy, rehabilitation, and disability treatment. The pool heater can reach 40°C but typically operates at 32-33°C, ideal for children's lessons and hydrotherapy.

With a well-established presence and purpose-built facilities, this swim school is designed for efficient operation and quality instruction. The freehold property ensures long term security, while the facility's layout and scope for expansion provide flexibility for future growth.
